1. Using photographs and other visual media

We will take photographs and, on occasion, videos of our events and activities.

We may ask for you to send in photographs of Grow Community – Sopwell events and activities that you or your family have participated in.

We will use a selection of these photographs online, including on Facebook, Twitter and any future website or Instagram feeds, and also in print both at events and activities and for promotional material. We will use visual media to celebrate events and activities that have taken place and to encourage people to come along and visit us. We may use them in grant applications.

2. Attributing photographs and visual media

Please include your name (let us know if you don't want your name shared) and a bit of information about the photograph/video so we can, where possible, attribute it to you. If the photograph wasn't taken by you, please ensure that you have permission to use and share the photograph.

3. Protecting our Community

Photographs/videos where people can be identified come under our GDPR policy. This means that we have to explain why we are taking the photographs, and ensure that photographs are not taken without people's consent.

For photographs at events, we will display a notice helping people understand their rights (Appendix 1).

For photographs at activities, we will ask people to sign a consent form (Appendices 2a and 2b).

Any photographs/videos that you send us of children or vulnerable adults must have the permission from that child's/vulnerable adult's parent, guardian or carer (not grandparent, other relative or friend). If no legal guardian is present, then we cannot take photographs of a child or vulnerable adult.

If at any point, you wish us to remove or delete a photograph/video with you or a child / vulnerable adult in your care in it or a photograph/video that you have taken, then please email us at growsopwell@gmail.com. The photograph/video will be deleted within a reasonable amount of time.

4. Terms and conditions

If you submit an image/video, you do so in accordance with the Grow Community – Sopwell's terms and conditions. These are:

You agree to grant us a royalty-free, non-exclusive licence to publish and otherwise use the material in our digital media and in printed material. You would still own the ultimate copyright and we will endeavour to attribute the image/video to you, unless you tell us you don't want your name mentioned.

5. The Policy as a living document

This Policy will be reviewed at least every three years and, where appropriate, the Policy amended as necessary.
